## KEEP AND RETAIN FOR YOUR RECORDS

### Annual Certification Fees – Crop Producers

As part of the certification process, annual certification, inspection, and user fees are assessed, as applicable, to your operation. All fees, including any add-on fees, are to be paid as part of the certification process. NICS offers a choice of two competitive fee schedules (explained below), which allows you to choose the certification fee option that best benefits your operation. Both options include a "Base Certification Fee" and "User Fees" based from your gross organic sales and/or services. Option 1 "User Fees" are based on your gross organic sales and/or services in the current year and is reported and paid on a quarterly basis. Option 2 "User Fees" are based on your previous year's gross organic sales and/or services (12 continuous months) and is a one-time payment submitted with your application fees. Once you choose Option 2 you cannot go back to Option 1 without approval and settlement of User Fees.

Option 1 – Crop Certification Fees

*Option 1 User Fees are .6% (.006) of all gross organic sales and services. This equals \$6 for every \$1000 of gross organic sales and services. The User Fee rate drops to .15% (.0015) for any gross organic sales and services over \$350,000 with maximum annual User Fees of \$10,000. Gross organic sales and services are to be reported to the office on a quarterly basis with applicable User Fees payable at that time, unless the Transaction Certificate System is used (in which case the User Fees are to be paid with the TC billing). You will receive a quarterly reporting form and must report within 30 days (even NO sales).*

Option 2 – Crop Certification Fees

*Option 2 User Fees are only for an updating NICS producer or a producer transferring to NICS from another certification agency who has been certified for a minimum of 12 continuous months and would prefer to report and pay annually rather than quarterly. Option 2 allows you to take your gross organic sales and/or services from the last 12 months and calculate your User Fees using the table below. Use the table below to locate the range of your gross organic sales and/or services to determine your annual User Fees. User Fees must be reported and paid with your Certification Fees and submitted with annual paperwork.*

**Option 1 Inspection Base Fee:** Both Option 1 and Option 2 require an Inspection Base Fee to be submitted with the Certification Fees. Total inspection costs include the base fee, applicable inspection expenses, plus a 10% administrative fee added to the total inspection costs billed by the inspector to NICS. Once we receive the billing for your inspection, we will invoice you for your inspection expenses and administrative fee.

**Option 1 Minimum User Fee Base:** If you have chosen to pay Option 1 certification fees, you will need to pay a minimum user fee associated with your organic certification request. Each operation under Option 1 certification fees plan will need to pay a minimum of \$30.00 towards their user fees. Reported sales will be calculated against the minimum user fee base until all the base fee is used for user fees.

An On-Farm Processor/Handler (excluding maple syrup) is any certified organic operation which processes or packages organic agricultural products produced exclusively on their farm to be marketed as organic. Certification and Inspection Fees for On-Farm Processors/Handlers processing are assessed as an addition to the Option 1 or 2 Certification, Inspection, and User Fees outlined above.

Maple Syrup certification requests are not required to pay On-Farm Processor/Handler Fees or Inspection Fees, but are required to pay the Maple Syrup Certification Fee (no additional Inspection Fee) as an addition to the Option 1 or 2 Certification Fees and User Fees outlined above. NICS reserves the right to charge additional fees, as applicable, for administrative and certification related services not specifically listed, and will be such additions will be charged at a rate of \$110/hour.

### Fee Definitions

**Uncertified Applicant:** This nonrefundable fee covers the additional administrative costs incurred by NICS when processing and evaluating an application for certification from an applicant who is not currently certified organic. This fee is required whether organic certification is ultimately granted or not.

**September 1 Certification Fee:** New NICS clients are subject to an additional certification fee if application materials are submitted to the NICS office after September 1. This fee is in addition to the Certification Base Fee and is nonrefundable.

**Administrative Fee:** Administrative Fees are assessed at a rate of \$110/hour for services such as, but not limited to: label review, adding additional products or services to an organic certificate, land adds after inspection, or other services provided outside of the normal scope of the annual certification process. Contact the office for more information.

**Returned Check Fee:** A returned check for non-sufficient funds is subject to a \$30 fee which includes the fee NICS is charged by our bank and NICS processing fee.

**Noncompliance Fee for Annual Updated Paperwork & Fees:** Annual update certification paperwork and applicable fees are due in the NICS office yearly by May 1. After May 1, noncompliance proceedings will begin and a \$200 fee will be assessed. Contact the office or refer to the NICS Certification Manual for more information about annual certification requirements.

**Late Paperwork Fee:** Late Paperwork Fees are assessed monthly beginning June 1, if annual update certification paperwork and applicable fees have not been received in the NICS office. Contact the office or refer to the NICS Certification Manual for more information about annual certification requirements.



**Reinstatement Fee:** A reinstatement request often demands the dedication of considerable staff hours. Therefore, those operations who are in need of reinstatement to the National Organic Program are assessed a Reinstatement Fee which covers staff time that is not considered part of a normal certification request. Reinstatement requests for suspensions which were issued strictly for failing to submit annual update paperwork and pay certification-related fees will be assessed at \$500. Reinstatement requests for all other suspensions are subject to a \$1,500 reinstatement fee. This fee is in addition to the certification fee and inspection deposit. Costs above inspection base fee are billed separately.

**Inspection Cancellation Fee:** If a scheduled inspection is canceled within one week (7 days) of the set inspection date, NICS reserves the right to charge a \$150 cancellation fee. Inspections canceled outside of the one-week window may be subject to additional travel cost. Please contact the office if you feel your inspection needs to be canceled so we may reschedule your inspection.

**Mediation Fees:** In response to a Denial of Certification, Notice of Proposed Suspension, or Notice of Proposed Revocation, an applicant or certified operation may submit a written request for mediation as a means of resolving an adverse action. A mediation request must be accompanied by the prescribed mediation fees in order to cover NICS' administrative costs associated with mediation. Mediation of adverse actions related to submitting annual update paperwork and certification fees is subject to a \$250 mediation fee. All other mediation requests are subject to a \$750 mediation fee. Additional costs incurred during the course of mediation, such as the hiring of an outside mediator, are assumed by the applicant or certified operation, no matter the outcome of mediation. Additional administrative fees may apply as applicable. Contact the office or refer to the NICS Certification Manual for more information about mediation.

**Settlement Agreement Verification Fees:** Successful mediation will result in the certified operation and NICS entering into a Settlement Agreement, wherein both parties agree to certain terms ensuring continued certification. Verification that the terms of a Settlement Agreement are being met requires additional administrative capacity and is therefore subject to a \$200, minimum, Settlement Agreement fee for each year the Settlement Agreement is being verified through inspection. Additional administrative fees may apply as applicable.

**Transaction Certificates (Import/Export of Goods):** Transaction certificates relating to the import/export of organic goods are load specific documents which validate your shipment(s) of certified organic products. Many countries require transaction certificates to import into their country. Sometimes transaction certificates are requested by the buyer and may or may not be required. NICS charges for the creation and issuance of transaction certificates. Countries which may require transaction certificates include, but are not limited to, the following: Korea, Switzerland, Japan, and countries affiliated with the European Union.

**Interest:** You have a 30-day interest-free period for fees charged, provided you have paid your previous balance in full. Balances past 30 day will be charged 1.5% monthly on the 6th day of each month.

## Refunds

*Producers wishing to withdraw their application or surrender their certificate may be eligible for a partial refund of annual Certification and Inspection Fees. Refunds, if applicable, will be pro-rated based upon the stage of the application at the time of the request. Please see the table below for minimum charges associated with each stage and contact the office if there are questions. Refunds, if applicable, will be issued once all associated charges, including inspection-related costs as applicable, have been calculated. Additional charges prior to refund may apply for add-on services requested, not included in the chart below. Finally, operations must be current with their user fee reporting; therefore, all gross organic sales must be reported, even if no sales have occurred, and paid, as applicable, to the office prior to refund processing.*

**"Certified Grass Fed" Add-On Services**

In addition to organic certification under the National Organic Program (NOP), NICS is pleased to offer our services in support of two (2) unique, add-on certifications intended to satisfying growing market demand for third-party verification of grass-fed claims. Inspection services are now being offered for operations pursuing certification under the American Grassfed Association (AGA) Certification Program, while inspection and certification services are available to operations seeking certification under the Organic Plus Trust (OPT) Grass-Fed Organic Livestock Program. Please learn more about each program below and feel free to contact the NICS office with any questions. Inspections for add-on services may be scheduled to run concurrently with your annual organic inspection, as applicable.

**American Grassfed Association (AGA) Certification Program**

The AGA Certification Program is open to both organic and non-organic producers of ruminants, for both dairy and meat, as well as pastured pork growers. Producers interested in applying for AGA Grassfed certification must first contact AGA at (877) 774-7277 to become members. Membership dues may apply. Once membership is finalized and you are issued a member number, then NICS may schedule your inspection. Under the AGA Grassfed Program, NICS provides inspection services only, and the AGA itself retains the final authority to grant or deny certification. Operations currently certified organic by NICS are eligible for a discounted inspection fee, even if their livestock is not certified organic. Please contact NICS or the AGA directly for more information about AGA Grassfed Program, its standards, or the application process.

**Organic Plus Trust (OPT) Grass-Fed Organic Livestock Program**

The Organic Plus Trust (OPT) Grass-Fed Organic Livestock Program is built upon a foundation of NOP certified organic livestock production and is therefore open to ruminant producers, both dairy and meat, whose livestock are either currently certified organic or transitioning to organic certification. Unlike the AGA Grassfed Program, the OPT Grass-Fed Organic Livestock Program does not have standards which cover pastured pork production. Producers interested in applying for OPT Grass-Fed certification should contact NICS to obtain an OPT Grass-Fed Supplement to their Livestock Organic System Plan. The OPT Grass-Fed Supplement must be completed and returned to the NICS office along with applicable fees prior to your inspection. OPT Grass-Fed inspections are intended to run concurrently with a NICS' certified organic operation's annual organic inspection. NICS is accredited under the OPT Grass-Fed Program to conduct inspections as well as make OPT Grass-Fed certification determinations. Please contact NICS for more information about the OPT Grass-Fed Program, its standards, or the application process.
